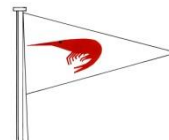

I agree to be bound by the Racing Rules of Sailing and all other rules that govern this event. In particular I have read the Notice of Race and confirm that I agree to its provisions and that my boat will conform to its requirements throughout the event.

I acknowledge that it is my responsibility to assess whether the event is within my capabilities and whether or not I may be endangered. I acknowledge that the safety of my craft and her entire management including insurance is my sole responsibility and I am satisfied that the equipment is adequate to face the conditions that may arise in the course of the event. I understand RRS Fundamental Rule 4: The responsibility for a boat's decision to participate in a race or to continue racing is hers alone.

I declare that I hold a valid and current craft insurance which covers me for third party claims in the sum of at least £2M whilst racing and that I will continue to do so whilst engaged in racing at Harwich Town Sailing Club.

I understand and agree that the race organisers [HTSC] shall not be liable for any loss, damage, death or personal injury howsoever caused to me as a result of me taking part in the event. The provision of safety equipment and boats by HTSC neither guarantees that assistance can be rendered to any competitor in need, nor an acceptance of any responsibility for rescue of competitors. Further, in the event that assistance is rendered to any competitor, HTSC nor the crew of such safety craft accepts liability for any loss, damage or injury to the competitor and/or the boat and its equipment.

I understand that if the boat is in the charge of any person other than the undersigned, it is the responsibility of the undersigned to bring the attention of the person in charge of the boat to the provisions of this entry form.
